Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check Eye contact

Inhalation Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Methods and materials for containment and cleaning up Small spill
