### Section 4. First aid measures

#### Description of necessary first aid measures

<b>Eye contact</b>	Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.

### Methods and materials for containment and cleaning up

**Appropriate engineering controls** Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
