Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Precautions for safe handling

- Advice on general occupational hygiene** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. - Conditions for safe storage, including any incompatibilities** Store in accordance with local regulations. 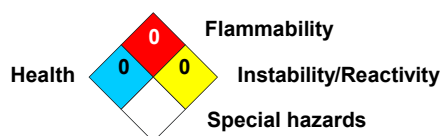
