Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Precautions for safe handling

- Advice on general occupational hygiene** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. - Conditions for safe storage, including any incompatibilities** Store between the following temperatures: 15 to 30°C (59 to 86°F). Store in accordance with local regulations. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. 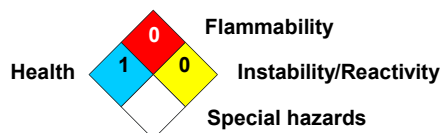
